



Sealed tenders in appropriate printed Tender Form are invited from the reputed enlisted of Cooch Behar Z.P. under Cooch Behar Zilla Parishad having experience in executing such type of jobs. However, copy of credentials of works done along with completion certificate etc. from the competent authority shall be required to be submitted along with application for tender paper.

1. The Contractors shall be required to supply all materials, required for proper execution of the work, if not otherwise mentioned and necessary Tools & plants, Masons and other skilled and unskilled labour of their own and shall arrange for necessary carriage of all the materials.
2. The Contractors are requested to inspect the site of work and acquaint themselves with the difficulties and peculiarities as prevailing at the site of work and quote their rate accordingly. All the works are located in difficult areas and so the inspection is very essential. No claim for any additional charges for such difficulties and peculiarities at the site of work, if any, shall be entertained after acceptance of tender. No price will be allowed for participation in the tender for the works under reference.
3. The Contractors shall quote their rates in figures as well as in words in the space provided, in the printed Tender Forms in percentage basis i.e. **ATPAR/BELOW** or **ABOVE** the rates of all items given in the Schedule for the work.

The Contractors are also requested to go through the drawings etc. in the Estimating Section before submitting their Tenders.
