The intending bidders must have valid Service Tax Registration no., Professional Tax Clearance Certificate and Value Added Tax/Sales Tax Registration no., PAN Card and Electrical License. The bidders must not have been blacklisted by any Government agency. Bid without earnest money shall be summarily rejected. The Tender Committee reserves the right to assess the bidders capacity and capability to perform the contract at any stage if required.

The Bid documents will be issued to the bidders from the office of Chief Medical Officer of Health, Cooch Behar between 11.00Hrs to 15.00Hrs on payment of the cost of Bid documents (non-refundable) during the period 05.11.2011 to 16.11.2011.

The sealed Bid documents shall be received in the abovementioned office up to **15.00Hrs on 18.11.211**, and will be opened **on that same day at 3.30 P.M.** in presence of intending bidders or their representative.

The participating bidders may please note that an amount equal to 1 %(one percent) of the gross value of work will be deducted from the R.A. Bills/ Final bill on account of “The Building and other construction workers (Regulation of Employment and conditions of Service) Act’ 1996 and the building and other construction workers Welfare Cess Act’1996” apart from other statutory deductions.

If the abovementioned offices happen to be closed on the date of receipt of application and/or the date of issue of the Bid Documents and/or the date of receipt of Bid Documents, the next working day (except Saturday) at the same time and venue shall be applicable for the said purpose.

The Tender Selection committee reserves the right to reject any or all tenders or to split up the works without assigning any reasons whatsoever and does not bind itself to accept the lowest tender.
